Meeting Minutes

Call to Order

Commissioner John Tinpe called the meeting to order at 6:32 PM.

Quorum

 Commissioners John Tinpe, Chairman, Theresa Harrison and Kevin Wilsey were present at the meeting confirming a quorum.

Agenda and Minutes

- Commissioner Harrison made a motion to approve the February 2018 meeting agenda. The motion was approved.
- Commissioner Wilsey made a motion to approve the January 2017 meeting minutes. The motion was approved.

Treasure's Report

• Commissioner Wilsey, Treasurer and Vice Chairman, announced that the ANC 2C opening balance for the budget in January was \$43,184.33. There was one expense paid; an outstanding check is still open (prior expense); and we received the Quarterly District Allotment of \$1,541.59. The closing balance for January is \$44,658.02.

Secretary's Report

- Commissioner Harrison, Secretary, announced that time allocation for speakers will continue for this meeting. Presenters who have Brief Community Announcements or will be discussing Local Events Impacting the Community will have five minutes to present. All other speakers will have 10 minutes to present. Community members will have one minute to speak and may only be called upon once during a presentation.
 - Commissioner Tinpe asked about the location of where meeting information is located. Commissioner Harrison stated that all meeting details (agendas, minutes, meeting audio recordings, and soon to be meeting resolutions) are located on the ANC 2C website (https://anc2c.dc.gov).



Brief Community Announcements and Presentations

- 1. Mayor's Community Liaison for Ward-2, Richard Livingstone (<u>Richard.Livingstone@dc.gov</u>) shared the following announcements from the Mayor's office:
 - February is Black History month and two events may be of interest: The Mayor will break ground on the new Fredrick Douglas Bridge; there is an unveiling of Fredrick Douglas portrait at City Hall. Go to https://dcarts.dc.gov to learn more.
 - Preparations for the city-wide budget are underway. The Mayor is hosting for opportunity for community members to comment on the budget.
 - Unveiling of the Marion Barry statue in front of City Hall will occur on Saturday, March 3 at 11:30 AM. Please RSVP for the event if you are interested in attending.
 - Commissioner Tinpe announced that on Sunday, February 18, is the Chinese New Year parade. The Mayor and Councilmember Jack Evans will be marching in the parade. All are welcome to attend.
- 2. Metropolitan Police Department (MPD), Captain Jonathan Dorrough (Jonathan.Dorrough@dc.gov) provided the following updates:
 - Lieutenant Jason Bagshaw was introduced as the new evening Lieutenant.
 - > Crime trends in our area were down overall in 2017 and the MPD did a great job. At the start of 2018 the numbers continue to be down in our area.
 - ➤ There was a homicide at 461 H Street on February 3. A suspect has been identified, he is considered to be homeless, and a wanted posted has been released. The homicide was domestic issue.
 - ➤ There was a stabbing at 461 H Street toward the end of January. This incident was an aggravated assault and was not related to the homicide. This incident is being covered by DC Housing Authority (DCHA) police.
 - Regarding the shooting that occurred on H Street near the Metro in December, that case is still open. The MPD has video footage but the quality of the footage is not good.
 - At Penn Social, toward the end of January, there was an altercation between patrons and a staff member. This matter was closed with an arrest. When an incident such as this occurs at an establishment selling alcohol, ABRA gets involved. The restaurant staff was helpful with information.
 - The Community Engagement Academy is now open for enrollment. The deadline to sign up by is March 7. This is a good program for the community to get a good look at how the MPD operates. To learn more go to: https://mpdc.dc.gov/release/community-engagement-academy

O Commissioner Tinpe asked if it would help to have a camera at 6th and H STs. Captain Dorrough said cameras are always good and there are a lot in the area however it would be good to have better cameras in the area. Commission Tinpe asked if the MPD has working relationship w/ the management Judiciary House (416 H St). Captain Dorrough said they have good relations w/ DCHA police, but not necessarily the management of that building. Commissioner Tinpe asked if people involved in the homicide were residents or visitors at Judiciary House. Captain Dorrough said one was a resident and one was visiting. Both men have long histories with the MPD.

Local Events Impacting Community

- 1. Marine Corps Marathon 2018 & MCM10K, Sunday, October 28, 2018, Jared Kline, Operations Coordinator (<u>Jared.Kline@usmc-mccs.org</u>), discussed an outline of the 43rd MC Marathon.
 - Commissioner Tinpe asked about street closures for 14th St. The team said 14 St. is closed until race is over. They said they stage clean-up crews within the race route to ensure immediate clean up. Commissioner Tinpe asked about the 3rd St., SW, closure. The team it is closed from 5:00 AM until last runner at 1:00 PM.
 - Commission Tinpe made a motion to send a letter or support. The motion was approved.
- Scope It Out for 5K, Sunday, March 18, 2018. Request for Street Closures: Pennsylvania Avenue NW, from 13th Street NW to 3rd Street NW, 3rd Street NW from Pennsylvania Avenue NW to Independence Avenue SW, Independence Avenue SW from 3rd Street SW to 7th Street SW. Jewel Hanson (Jewel Hanson@msn.com) outlined the race details.
 - Commissioner Wilsey asked if the set-up was only on Pennsylvania Avenue. Jewel said there is a little set up on Freedom Plaza.
 - Commissioner Tinpe asked if there are rolling street closures. Jewel said that in some places, yes there are rolling street closures. Commissioner Tinpe asked how many years have they done the race? Jewel responded with five year.
 - Commissioner Wilsey asked if the streets are open sooner? Jewel said yes, the course is opened as soon as available.
 - Commissioner Tinpe made a motion to send a letter or support. The motion was approved.



- 3. St. Patrick's Day Parade, 47th Annual Parade, 5,000 people estimated to attend. Sunday, March 11, 2018, 12 noon- 3 pm. Street Closures: from 10 am 2 pm, at 7th Street NW between Independence Avenue SW and Constitution Avenue NW, Constitution Avenue NW between 7th Street NW and 17th Street NW. Stephen Petruccelli (<u>stephenpetruccelli@gmail.com</u>) discussed the parade details. This is the 48th year of the parade.
 - Commissioner Tinpe made a motion to send a letter or support. The motion was approved.
- 4. Rock N Roll Marathon 2018 and ½ Marathon, Saturday, March 10, 7:00 AM, starting at 14th Street and Constitution Avenue NW. Diane Romo Thomas (<u>Dianeromo-thomas@hotmail.com</u>) discussed the race details.
 - Commissioner Tinpe asked about how the race handles road closures across the city for some of the major roads. Diane mentioned that they post signage and keep people moving in and out with as little impact as possible.
 - Commissioner Wilsey asked if 12th street open? Diane said no and once the race starts then it will open around 10:00 AM or thereabouts.
 - Commissioner Tinpe made a motion to send a letter or support. The motion was approved.

 - o Commissioner Tinpe asked what kind of alcoholic beverages will be served. Jeffrey said beer, wine and some mixed drinks. Commissioner Tinpe how will you notify people visiting DC where your main door is located since your address is Pennsylvania but the door is on E street? Jeffrey said they are working w/ the Department of Consumer and Regulatory Affairs to provide an electronic marker via Google Maps that shows E Street as the front door.



 Commissioner Tinpe made a motion to send a letter or support. The motion was approved.
