   This hotel will have 11 floors, 265 rooms, no parking, commercial loading, in the back from the alley, and front entrance on H St. Plan will present before the Office of Planning on June 10. H & K did not notify adjacent neighbors, as stated. H & K failed to receive neighborhood support. Motion to support: 1 yea (Closter) and 1 abstention (Tinpe).
- 2. Monument Realty, 608-624 Eye St NW, 613-617 H St NW, new design Per HPRB, by Kirk Salpini. The new plan reduced massing, changed to keep a minimum distance of 25 ft from neighboring Wah Luk House. There is a new entrance to the loading dock. The new plan to include a Community Room which is to be used as appropriate.
