DDOT (by Maria Salaam and Howard Chang)

Proposed "North/South Corridor", Street car to run from Buzzard Point (proposed Soccer Stadium) to Takoma, DC. A number of community meetings to take place in November.

Question by Jo-Ann Neuhaus: "Where will it be in Penn Quarter?"

Planning, Zoning and Environment

1. Verizon Center Signs, Robbie Sabbakhan, DCRA and Alice Kelly, DDOT.

Kevin Wilsey: "How was the billboard put up without going before the ANC?"

Robbie Sabbakhan: "I have to go back and look at the verification."

Harold Closter: "What are the logistics?'

Alice Kelly: "We don't know the impact, so what to expect, after the fact, the potential impact on traffic, auto and pedestrian."

Nanette Paris, Clara Barton resident, formerly of the Downtown Neighborhood Association:

"Brightness and size unexpected. In Nov 2012 ANC passed the resolution."

Tim Bellamy: "FHWA was clarified. Verizon went to FHWA. Verizon Center's full motion is legal. 7th St NW is a Federal Highway."

Community Testimony

Ana Molina, CFO, ESA, 575 7th St NW, Venable Building

"My window is facing F St NW,.. been tenants for a while, conditions impede ability to see, vision to a blur, reflects on everything. Please analyze impact. Possibly, decrease in value."

David Julyan, Esq., Terrell Place

"The right balance between revenue and quality of life of neighbors should be achieved. Travesty of the system, the process by which was brought. Full motion with video brightness, this was not dictated during the process. Digital billboard-static display is what is mentioned. Full Motion Video is not digital display." The process, ...

"When Monument was unsuccessful in getting DDOT's approval, they had separate meetings with Council and Administration. But no Full Motion Video was authorized. Monument went to Council Member Jack Evans to press for Full Motion Video. Council authorized Full Motion Video. NCPC's 1995 Agreement states, any changes to exterior will come before the NCPC. After installation, DDOT has been initiating action to review. Recommendation to exercise legal authority in mixed use community."

Elizabeth Miller, NCPC, Gallery Place resident,

"Light reflects off the buildings, from Verizon Center and Gallery Place, it is like living in a pin ball machine."

ANC Harold Closter: "What would prevent any establishment from putting up a sign of similar kind?"

DCRA Robbie Sabbakhan: "No. Everyone has to comply with our codes, by passing ANC is not the norm."

ANC Kevin Wilsey: "There was a process and rules were put in place. Rules were by-passed." DCRA Robbie Sabbakhan: "We are transparent."

DDOT Alice Kelly: "We have been involved with sign regulation rewrite. There has been a built up demand. Develop a more engaging process. Gallery Place and Verizon Center were exceptions."

Randy Boe, Monumental Sport Board, Verizon Center:

"The signs did not happen overnight. I have always answered the questions. We are willing to talk. The fourth sign is up. We can visit the issue again. I can come back. The process should be transparent, illumination level et al. We talked about Full Motion. NCPC believes they have jurisdiction-we believe they do not. Did this happen over night? DDOT is involved, DCRA is involved."

ANC Kevin Wilsey: "Will you be willing to look at the brightness and decrease the light along the duration?"

Verizon, Randy Boe: "Yes. I think the illumination will have the light dimmed to a garage level." Motion: To send to DDOT to reassess brightness. To send to NCPC, letter seeking advisement. All were in favor of motion, (unanimous.)

Sean Cahall, owner, SVP, Property Group Partners,

"Putting back to a new and relocating where it was prior to 1969."

Now seeking support for the Second Stage.

ANC Harold Closter: "What will be the traffic impact? On 3rd St ramp? On Mass Ave?" PGP Sean Cahall: "Entrance will be at 4th and Mass Ave. Exit will be at 2nd between F and G St." Please view National Environment Project Admin.(NEPA), link S&D Capitol Crossing. All were in favor of support (unanimous.)

3. Monument Realty, 609-619 H St NW, 610-624 I St NW, HPA#13-627, Proposed Plan for Demolition, presented by Kirk Salpini, Monument Realty,

Proposed demolition plan of existing 609-619 H St NW. To be replaced by single office and retail building. Public alleys between H and I St, to be enclosed as part of the building. Public alley connecting H and I St to become a private walk way.

Parking concerns: looking to move in 9 to 18 spaces. Commuter concerns: route in alley to stay open at all times. Building is 90ft in height, 8 stories.(Neighboring 6th St Flats is 7 stories.)
